# Executive Summary

## Connecting across Virginia

Blue Ridge Partnership for Regional Invasive Management (PRISM) began in 2014 as an idea to build a partnership around caring for forests by controlling invasive plants. In the seven years since those conversations, PRISM has grown into a respected authority on invasive plant management for individuals, communities, landowners and conservation professionals.

This past year was transformative for PRISM. On October 1, 2020, PRISM officially separated from Shenandoah National Park Trust, our long-time fiscal sponsor and partner. Fiscal year 2021 was our first as an independent 501(c)(3) public charity. PRISM took on new opportunities to work on invasive plant policy issues through House Joint Resolution 527. Joining with the Plant Virginia Natives Marketing Partnership to host the *Landscaping with Virginia Natives Webinar Series*, PRISM connected to new audiences across the Commonwealth.

Because of the pandemic, PRISM explored virtual options of connecting with its audience. PRISM's Online Quarterly Meeting on Winter Invasive Plants in January 2021 broke a new attendance record while our online invasive workshops were popular. PRISM's increasing audience reflects a growing concern from the public around invasive plants and their impacts on Virginia's natural resources.

In-person events were slow to return after 2020. In a collaboration with the Charlottesville Area Tree Stewards (CATS), a new invasive field session was developed and launched in September. We will continue to plan more events and meetings in person with landowners and anyone concerned about invasive plants while continuing to offer a variety of virtual events.

The dedicated staff and volunteers of Blue Ridge PRISM are pleased to share with you our work and successes during this transformative year. None of this would be possible without the support of our partners, volunteers, and you. We look forward to another successful and exciting year of assisting you and mitigating the impacts of invasive plants in the northern Blue Ridge Mountains and across the Commonwealth.

# Public Education Programs

## Education and Outreach



Education and outreach is the heart of Blue Ridge PRISM's work as an organization. We believe that educating landowners about the negative impacts of invasive plants will lead to more landowners managing invasives on their properties, thereby reducing the harmful ecological effects of invasive plants in our region.

The impact of the COVID-19 pandemic continued to impact PRISM's ability to do traditional in-person outreach activities such as large community events, educational workshops, partner events, and our Quarterly Meetings. Quarterly Meetings, seasonal invasive workshops, and speaking engagements went virtual in March 2020. Some activities such as on-the-ground invasive control

projects and landowner consultations continued. In September, we were able to host our first in-person Fall Invasives Workshop at Azalea Park in Charlottesville. Appendix A provides details about specific activities.

## Quarterly Meetings

PRISM held Quarterly Meetings that were free and open to the public. In addition to PRISM updates, programs are designed to educate and inform our audience about new or common invasive plants, management techniques, ecological restoration, and current research. Attendance of our Quarterly Meetings for this year was 678. PRISM's FY 2021 Quarterly Meeting topics are highlighted below.

## Speaking Engagements

Through speaking engagements, PRISM connected a broad audience of conservation groups, homeowners associations, and landowners with resources such as in-depth information about the ecological impact, identification, and management of invasive plants.

PRISM had the unique opportunity to be a lead partner in the *Landscaping with Virginia Natives Webinar Series* along with Lewis Ginter Botanical Garden and the Plant Virginia Natives Marketing Partnership. PRISM supported this webinar series by hosting the keynote address from Dr. Doug Tallamy and giving the presentation, *Invasive Plants in Virginia: Resources, Spring Identification, and Native Alternatives*, as part of the series. This webinar series introduced Blue Ridge PRISM to audiences across Virginia and specifically reached home gardeners alerting them to the issue of using invasive plants in landscaping. Over 3,000 individuals registered for this popular webinar series.

PRISM was invited to 16 speaking engagements engaging with 1,569 individuals. Appendix A provides specific details for each speaking engagement.

## Educational Events

The virtual invasive workshop was restructured and divided into three separate sessions that launched in September 2021. The sessions were designed to be taken together or individually, depending upon the needs of the participant and offered a deeper dive into the content. The *Introduction and Identification of Invasive Plants* and *Control and Management of Invasive Plants* were offered virtually. A new field session for the workshop series was developed in collaboration with the Charlottesville Area Tree Stewards (CATS). The field session covered all of the elements of the virtual sessions and allowed participants to meet with PRISM instructors, ask questions, learn invasive

identification, and discuss tool and herbicide safety. The virtual format has overall dramatically expanded PRISM’s workshop audience, drawing participants from around Virginia and other states. PRISM hosted ten Invasive Plants Workshops with 384 attendees, about the same as last year’s workshop attendance.

## Financial Assistance

### Regional Conservation Partnership Program (RCPP)

In 2016, Blue Ridge PRISM under the Shenandoah National Park Trust entered into a RCPP Agreement with USDA Natural Resources Conservation Service (NRCS) to direct additional funding to landowners in PRISM's 10-county region. Blue Ridge PRISM received no funding from the RCPP Award.

As of September 30, 2021, NRCS reported there were five active contracts, 77 contracts completed, and 2,180 contract acres reported in Albemarle, August, Clarke, Greene, Madison, Nelson, Rappahannock, Rockingham, Page, and Warren Counties. Practices included brush management, herbaceous weed control, and forest stand improvement. The Virginia Department of Forestry has been a critical partner assisting NRCS, Blue Ridge PRISM, and landowners to implement this program.

With the help of our partners and volunteers, PRISM met and well exceeded the match requirements for the RCPP Award. PRISM, our partners, and dedicated volunteers generated in kind matching funds totaling \$2,201,336.01.



This program was to conclude in September 2021; however, it was extended by NRCS for an additional year to complete the remainder of the work.

## Regional Early Detection and Rapid Response (EDRR)

### Wavyleaf Basketgrass Rapid Response

Blue Ridge PRISM continued leading the effort to control and eradicate invasive wavyleaf grass during the summer of 2021. Working through conservation partners, contractors, and volunteers, over 600 acres of wavyleaf basketgrass have been brought under active management.

PRISM has secured two grants to directly fund control efforts of wavyleaf basketgrass. As part of the DuPont Settlement (USFWS), PRISM was awarded \$250,000 over a five-year period to implement control work on six wavyleaf basketgrass sites. This funding supported wavyleaf control work in Shenandoah National Park. Through the Virginia Department of Forestry, PRISM received an additional three-year \$45,000 grant to expand wavyleaf work to other sites including some in Albemarle County through 2022. PRISM volunteer Jim Hurley assisted by managing the contractors and coordinating with Conservation Legacy, a contractor partner who arranged the participation of the Harrisonburg-based Appalachian Conservation Corps (ACC).

# Projects and Partnerships

## Preventing the Sale and Planting of Invasive Plants

### Noxious Weeds Advisory Committee

In addition to serving on PRISM's Leadership Team, Ruth Douglas, Rod Walker, and Jim Hurley also serve on the Noxious Weeds Advisory Committee for the Commonwealth of Virginia. This committee recommends to the Board of the Virginia Department of Agriculture and Consumer Services (VDACS) changes to the noxious weed regulations and carries out detailed assessments to justify recommending specific plants to be added to the official noxious weeds list.

PRISM coordinated the nomination of ten new invasive plants. Volunteers were invaluable in researching and preparing the detailed assessments required as part of the nomination process. Plants nominated were *Microstegium vimineum*, *Elaeagnus umbellata* (photo right), *Lonicera maackii*, *Paulownia tomentosa*, *Alliaria petiolata*, *Commelina communis*, *Lespedeza bicolor*, *Lonicera japonica*, *Reynoutria japonica*, and *Securigera varia*.



### HJR 527 Invasive Work Group

During the Virginia Legislative's 2021 Special Session, House Joint Resolution 527 was approved:

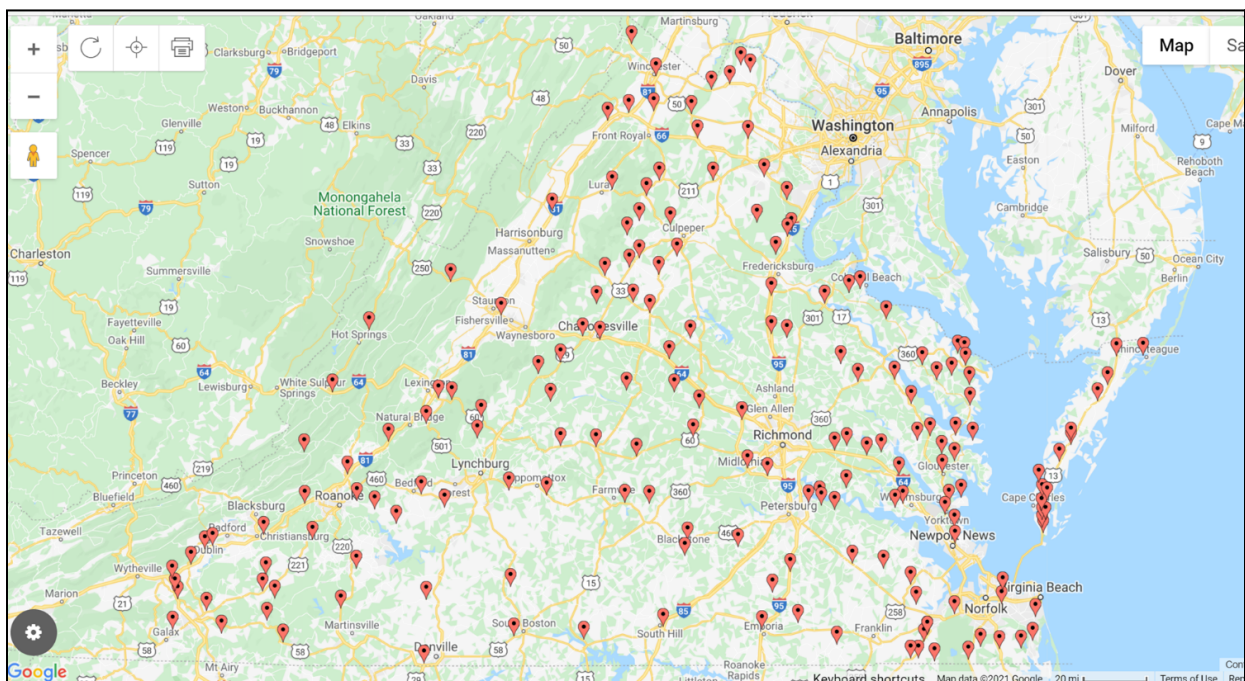
*Requests the Department of Conservation and Recreation, jointly with the Department of Agriculture and Consumer Services, to establish a work group to study the sale and use of invasive plant species. The resolution requests that the departments work with several state agencies, conservation nonprofits, and plant industry and agriculture groups to develop recommendations regarding statutory and regulatory changes*

*intended to reduce or eliminate the sale and use of invasive plant species in the Commonwealth and promote the sale and use of native plants.*

Blue Ridge PRISM along with our partners at the Virginia Native Plant Society and the Audubon Society of Northern Virginia was instrumental in getting this resolution passed. PRISM volunteer Rod Walker served as PRISM’s representative to the work group. Meetings began in June 2021. The final recommendations are expected to be released in early 2022 and submitted to the Governor and Members of the General Assembly.

## Virginia Department of Transportation (VDOT) Partnership

In 2018, PRISM began working with VDOT to address the planting of invasive plants alongside roadways in the state. Other agencies in this planning process included the Department of Conservation and Recreation, Virginia Native Plant Society, Virginia Tech, and the Department of Environmental Quality. Virginia Tech began their study, *Promoting Native Roadside Plant Communities and Ensuring Successful Vegetation Establishment Practices*, in February 2021. In September, the researchers reported the project was well underway. They have completed a literature review, gathered information on VDOT vegetation practices and procedures and have assessed 182 areas of interest (AOI) for plant community data and other relevant information. Blue Ridge PRISM participated on the project’s technical review panel.

## Using Drones for Invasive Plant Detection

In 2019, PRISM began working with the University of Virginia and other partners to pilot use of drones to map invasive plant species. The current research is focused on using hyperspectral cameras to survey a testing area, building a library of spectral reflectance signatures during differing points of the growing season, and developing algorithms to detect certain plants. Partners met in October 2020 for an update from the researcher, Kelsey Huelsman.



At Blue Ridge PRISM's Spring 2021 Quarterly Meeting, Kelsey gave a presentation about her research, *Drone Based Hyperspatial Remote Sensing to Identify and Map Invasive Species in Virginia*.

## EDDMapS - Virginia Invasive Mapping Initiative



In July 2021, Blue Ridge PRISM and our partners, Virginia Master Naturalists (VMN), Virginia Department of Conservation and Recreation – Natural Heritage, and EDDMapS launched the Virginia Invasive Mapping Initiative to collect data on the type, distribution and spread of potentially invasive plants in Virginia. The partners developed a training specifically for VMNs to become invasive plant mapping project leads for their local chapters. Students learned how to use the EDDMapS app and lead their local chapters in collecting invasive occurrence data. The project was approved as an official volunteer project of the VMN program



# Blue Ridge PRISM Operations

## Staffing and Organization

Blue Ridge PRISM is supported by two staff, volunteers, and partners who help manage PRISM day-to-day operations, lead volunteer training and events, and direct the overall organization.

Blue Ridge PRISM employed one full-time Program Director and a part-time Communications Coordinator.

### Communications

Blue Ridge PRISM has dramatically increased our audience through social media and our outreach programming. As of date, our mailing list has grown by 780 individuals since September 2020. Social media interactions have jumped with 272 Facebook posts which had over 300,000 views.

## Social Media

PRISM engaged with our audience through Facebook to disseminate information like Weed Alerts, upcoming meetings and workshops, and partner events. Social media amplifies communications by sending them to an audience beyond our email communication network. Here are a few highlights from FY 2021:

Facebook Posts Made During Reporting Period: 272

PRISM Facebook Posts Viewed: 311,470 reached (The same person can view multiple posts, so in this case the number is not necessarily reflective of the total number of individuals reached.)

Most successful Facebook post: Don't buy this plant -- Nandina/Heavenly Bamboo was posted on February 28, 2021 and reached 81,587 individuals.

PRISM's presence on social media has steadily grown. This past year our number of Facebook followers has grown to 1,378.

## Newsletters and Alerts

Email is also an important communications tool. By the end of FY 2021, our subscriber list had grown to 2,584 individuals.

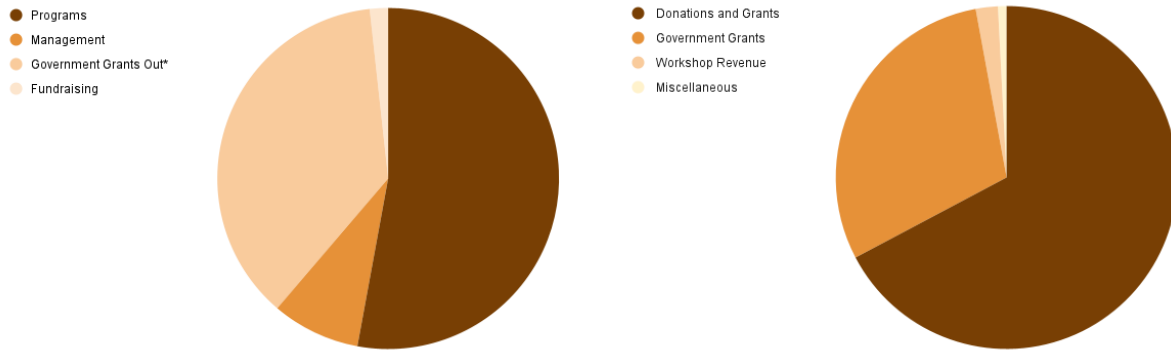


## 2021 Financials (Fiscal Year 2021)

Expenses: \$190,175

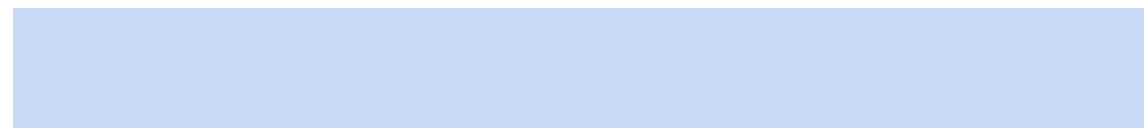
Revenues: \$270,191
